### **Summary of Job**

Global leader of environmental and EHS audit programs to minimize risk and liability to PB.

### **Accountabilities**

- Manage site investigation and remediation projects globally (planning and implementing large, multi-phase projects that involve large amounts of analytical, hydrogeological, and investigative data)
- Manage superfund site projects and consultants
- Coordinate site and facility closures
- Prepare 10k report information / environmental accruals
- Maintain budgets and cost estimates for all remediation liabilities and projects
- Provide technical expertise in the development and implementation of remediation strategies with a focus on cost-effective, practical solutions
- Manage outside consultants and interface with inside/outside counsel
- Regulatory and technical negotiations at both the U.S. EPA and State Regulatory agencies regarding the scope of investigation plans and reports.
- Lead environmental due diligence for acquisitions and divestitures globally
- Participate in the development of environmental agreements, APA conditions, and general contract review for environmental requirements
- Lead Phase I, II and other environmental site assessments for real estate transactions
- Apply risk management tools and criteria for site investigations, cleanups, and liability evaluations.
- Conducting public presentations of project results during community and regulatory meetings.
- Develop and implement EHS audit program (globally) for:

- Manage issues related to mold, asbestos, radon, and lead-based paint for multiple sites
